BOARD OF EDUCATION MEETING  
JANUARY 28, 2019

CALL TO ORDER: The Board of Education of Unified School District No. 422, State of Kansas, Kiowa County, met for a regular meeting at the school district office, 710 S. Main Street in Greensburg. The meeting was called to order by President Ki Gamble at 8:00 p.m.

- STUDENTS REQUEST BASEBALL:** Students Caydan Pore, Connor Pore and Bryson Brown made a proposal to the board in support of adding baseball, and possibly softball, to the list of school-sponsored athletics. The board president commended them for their presentation, which he had prefaced by explaining that a decision would not be made at this meeting or the next because the board and administration would need time to gather information.
- PROPOSED CALENDAR:** The superintendent shared a preliminary draft of the 2019-20 school calendar.
- PARENT SURVEY:** The superintendent reviewed data collected in a parent survey as part of the school accreditation process.
- REPORTS:** Principal Travis Powell reported on the SPIAA Basketball Tournament and Big Read awards. He also announced that Greensburg State/SJN Bank will be sponsoring admissions at the February 1 Basketball Royalty game.
- Superintendent Staci Derstein reported that she has received notification of the corrections needed following the recent Civil Rights Audit. She also reminded the board of the upcoming Friends of Education Charitable Trust silent auction.
