BOARD OF EDUCATION MEETING
JULY 18, 2023

CALL TO ORDER: The Board of Education of Unified School District No. 422, State of Kansas, Kiowa County, met for a regular meeting at the school district office, 710 S. Main Street in Greensburg. The meeting was called to order by President Ki Gamble at 8:02 p.m.

APPROVE AGENDA: A motion was made by Paul Kendall and seconded by Mike Greenleaf to approve the agenda with one addition:
